Signia was originally established in London in 1994 as a Chartered Accountancy practice by its founder.

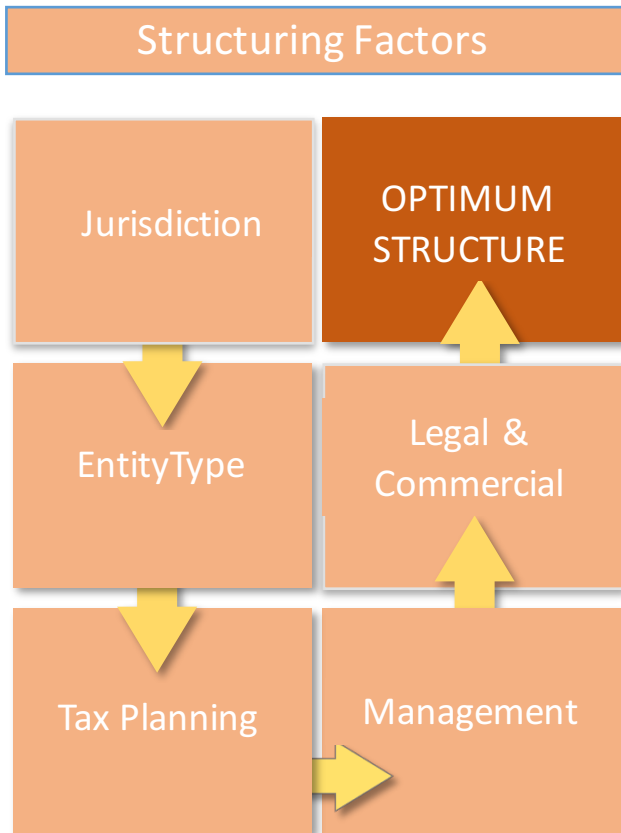
The firm developed a track-record of success in international advisory services leading to the relocation of the HQ to the UAE in 2011 providing an ideal base for Financial Services Without Borders.

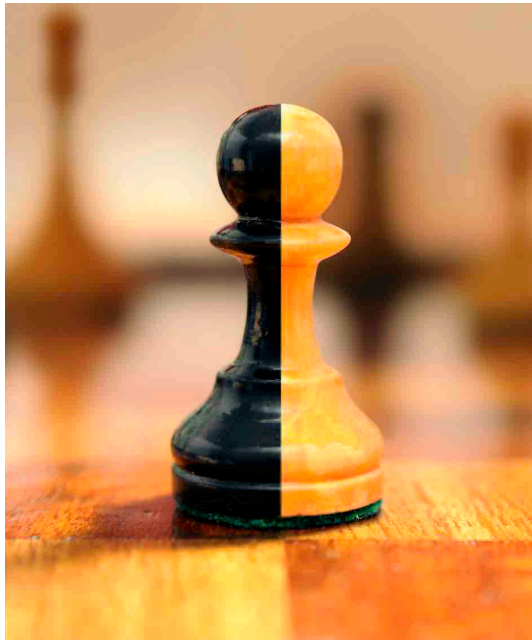
